#### October 6, 2016 Judge Mark Davidson The Incredible Importance of Rotting Papers: Historical Court Records of Texas

Judge Mark Davidson served as Judge of the 11th District Court for twenty years before his retirement in 2009. He is now serving as the Multi-District Litigation Judge for all asbestos cases in the State of Texas, being named to that position by Chief Justice Wallace Jefferson and the Multi-District Litigation Panel of the Texas Supreme Court. In that role, he has judicial duties over the 85,000 asbestos cases pending throughout the state.

The third Saturday of September is designated as Texian Navy Day; this year that day was September 17. The SRT held its annual Honor Day Ceremony at the Battleship Texas, honoring those Texas heroes who served our state through the Texas Navy. The activities then moved to Galveston to the Fisherman's Wharf Restaurant where the Commissioning Ceremony for new Admirals in the Texas Navy took place. The beautiful room setting and ceremonial activities made this year's Commissioning Ceremony a memorable one for all involved.

Organized and orchestrated by San Jacinto DRT member (and an Admiral in the Texas navy herself) Beth Fisher and Texas Navy Association Vice-President Admiral Richard Hatch, the ceremony featured a red carpet, a traditional Navy side-boy honor guard, and the ringing of the bell which once graced a Navy vessel. The event, which included a wonderful buffet, featured Mr. J.P. Bryan, of the newly opened Bryan Museum in Galveston, as guest speaker. Our own San Jacinto DRT Chapter member Laura-Hill Taylor led the singing of the National Anthem and "Texas, Our Texas". San Jacinto Chapter members Luanne Zacek and Susan Stormer assisted Beth Fisher with registration.

Seven honorees were commissioned as Admirals in the Texas Navy in honor of their service to Texas by their diligence in helping preserve the history of Texas. Among those honored was Nina Hendee, who is an Honorary Member of the San Jacinto DRT Chapter, and will be presenting a program at the April meeting.
